The added value from a highly motivated person is 5-10 times more than usual.

Sources (reasons):

- First
- Second
- Third
- Fourth
- Fifth (additional)

Analogy (at the country level)

First source:

Ordinary surplus value is produced from the energy of people who are in one of two psychological states: or anxiety (= "failed" sections of the population), or boredom (= "wealthy" sections of the population).

MANY times more energy is born in a state of inspiration. You can get high inspiration like this:

approval by society / the surrounding social environment of the results of effective human activity and man's lack of fear that the result of his activity will be taken away.

Proof: children play with maximum dedication (in those games in which they receive praise from fans and judges).

Second source:

Lack of economic dangers and fears

will lead to the fact that a Person will not "stop and look Back" during activities which will increase its return by another 1.5 times.

Proof: just thoughts on the topic of money/welfare take away 1/3 of an ordinary worker's life. Even when he works, a significant part of his attention is not in work.

1/3 attention = 50% of the remaining, so directing attention to activities alone will give an increase of 1.5 times.

Third source:

The desire to play a "favorite game" = to engage in a favorite activity, will lead to the most effective redistribution of labor in the country by type of activity, which will significantly increase the output of the collective" workforce.

Fourth source:

The maximum possible reduction in losses due to ineffective superior-subordinate relationships. The boss ceases to be a source of wealth,

and the subordinate ceases to be a means to ensure the well-being of the boss. The boss will refuse to work with an ineffective subordinate, and the subordinate will refuse to work with an ineffective boss.

As a result, companies will consist ONLY of people who want to work with each other = a single team. (Imagine: ALL companies and institutions consist of truly united teams!)

Fifth source. (additional)

Any important decision in companies goes through more than one approval.

Agreements between people, when everyone thinks about their own interests, doom the most promising solution to failure, and a "golden mean" decision will be made.

When the decision is made by those who are striving exclusively for a common goal, then inevitably the MOST effective decision will be made.

This will increase the return from the collet Worker by several times more.

Sixth source. (additional)

Many companies live on the phenomenon of "bargaining" for a long time. In conditions of government prices, there is no point in bargaining.

Companies will be forced not to wait, but to start improving their efficiency.

Historical examples prove that in the presence of the above conditions, the effectiveness of even small groups increases 10 times!

Change in activity MOTIVATION for EVERY resident (civilizational change):
not with money, but with an assessment of the social usefulness of the individual.

1) Becomes the yardstick **Personality Utility Index (=PUI)** ---

PUI of the Manufacturer \ Seller = average rating of the product by the Buyer (on a smartphone).

2) The seller of any value DECIDES HIMSELF: to whom to give or not to give the product of his labor (guideline - PUI).

3) Consumer values are distributed free of charge: **"New" money in the consumption sector is abolished** ---,
including :

-- the replenishment of individual accounts (with exceptions),

-- the accounts of individual entrepreneurs are transformed in the account of companies:
otherwise they will have nowhere to enroll the revenue from the given commodity values.

"Sedative" features:

4) the seller can accept values equivalent to money (for example, gold),

But since replenishing goods is usually more convenient for non -cash, sales for non -jealous will be an exception,
Which does not affect the motivation of the bulk of the working population.

5) the consumer can spend the rest of the money in the same order from his account until the money ends there;
Citizens can put money on their accounts before the reform - as much as they want: make a psychological "reserve" for themselves.

6) Companies can buy from a person belonging to his gold at the price of the department with the crediting of funds to his expense account. But money to maintain business is sufficient money that is better than any product form, so only specialized companies will buy gold. And from this the bulk of the workers will not be worse.
And the owner of "cashed" gold will be able to acquire consumer values outside the index.

7) **Phenomenon will appear "auto" detecting violations of the reform law.** ---

Personality Utility Index (=PUI).

PUI = Average of numerical form of opinions (likes and dislikes)

Any product, work, or service is rated by the Consumer using a smartphone/or computer

PUI =

anonymous: The seller does not know who exactly valued it;

each new assessment is immediately taken into account in the person's PUI;

Everyone's PUI is visible to everyone

The evaluation of the company's product is taken into account in the PUI of EVERY employee of the company. Total rating of a company employee = average of ratings for all company products

PUI takes into account both quality and quantity

Abuse

How PUI is formed in representatives of different types (not) activities

PUI should also be used as a tool to reward citizens for rendered great services to country.

For example, a maximum PUI is set for a certain period of time; and so on.

Not a single potential falsifier will even think in this direction_

For example: someone demotes or promotes someone with false negative ratings.

Why won't this happen as a phenomenon?

Causes:

1) since it is not the person who is being evaluated, but the product, it will not be easy to falsify the PUI for someone personally;

2) falsification of assessments will be condemned by society, which will ultimately lead to a decrease in the falsifier's PUI (: word of mouth will do its job).

Knowing this, not a single potential falsifier will even think in this direction.

Continuously increasing influx of qualified labor different branches of human activity (= universal surplus value).

Moreover, together with their families - to LIVE, and not temporary workers.

Reason: psychological fatigue from worrying about your future because of money (especially in industrial countries: where the vast majority of the population cannot feed themselves from nature: they live and work in cities.)

maximum efficiency due to the self-formation of strong and long-term "teams":

Reason: no one is interested in working with an ineffective employee, therefore,

or the team will only take on equals,

or a highly effective employee will leave for a stronger team.

--

a significant increase in workforce productivity due to the release of a significant part of time from financial worries.

An ordinary worker spends at least 1/3 of his time on money worries (even when working). If he starts spending this time on work, then even an extensive effect will give an increase in productivity by 50%: $(1/3) / (2/3)$.

Difficulties and features of the transition period of reform.

The main difficulty is to start. Reason = fear of uncertainty, including fear of rapid change. Solution = do not replace reform with preparation for it:

- dispel the first doubts: let the Minds ask the first questions and receive an answer;
- do not allow the second, third, etc. circles of questions: if the answers are given to the main thing. then even more will be given for secondary things.
- and start ("in the fog you can only see the road when you walk").

Transitional period of labor redistribution in the country: 1/6 of workers will change jobs, therefore a temporary imbalance may arise in the supply of labor to sectors of the economy.

Solution = prompt government involvement in "closing the holes";

Initial conditions. (including)

- Smartphones must be owned by 85% of buyers;
- 85% of companies must have corporate bank accounts;

Preparation (including)

- It is necessary to have a database on the composition of employees and owners of at least 95% of companies;
- It is necessary to form a Department for determining consumer prices (3-4 people). [One of the employees must be a representative of the central financial authority.](#) ---
- It is necessary to ensure the availability of applications in smartphones about: consumer prices, categories of consumer goods and the Human Utility Index.

One of the employees must be a representative of the central financial authority.

For the efficiency of any changes, it is necessary that decision makers had a complete and up-to-date understanding of what was happening. This is only possible when a central banker works together with state employees.
This needs to be resolved with the Central Bank.

The tourist pays as usual: a foreign card or in cash.

Money

--from the card are credited to the seller's account with automatic conversion

--cash are placed at the expense of the seller's company.

The seller has no right (and interest) not to sell to the tourist what he wants.

Outbound tourism.

or from balances in expense accounts.

or at the expense of the state (society): an amount is issued, the size of which depends on the value of the social utility index.

Calculated by the department based on the market price of the type and duration of the trip in the country where the departure takes place.

For this purpose, statistics from travel companies adjusted to the Index are used.

For holders of the maximum index, there are no restrictions: how much you spend, which means that's what you need. Note: business trips are at the expense of the companies.

the bad:

in a situation where the part of the population that is against the reform is larger than the part of the population that is "for" the reform: a referendum is held. If the results of the referendum are "against" the reform, then the reforms are cancelled.

the good:

The proportion of reform supporters is greater than those of opponents. And it grows over time. Seeing this in every smartphone will reassure supporters that the reforms are long-lasting.

After a stable twofold excess of supporters over opponents, a new public morality is formed.

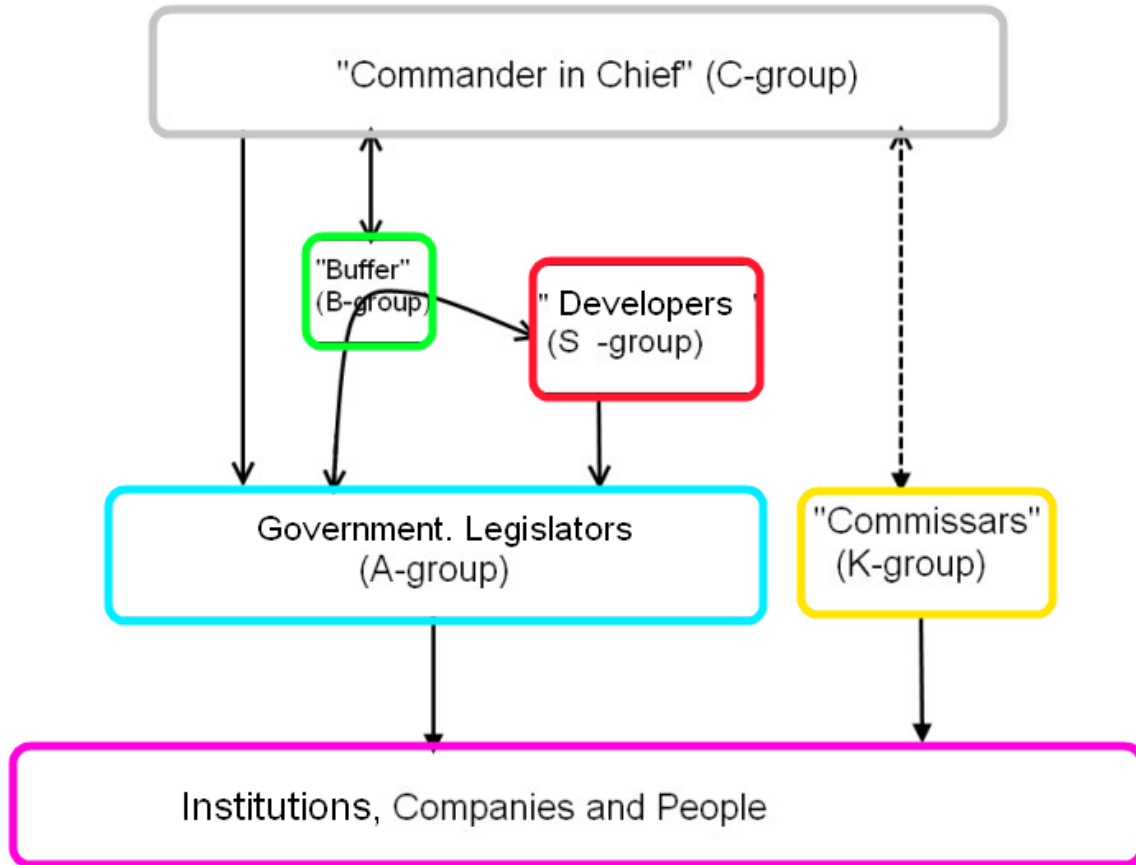

Appoint and change group members.

Regarding members of group "B" and group S:
[at the request of any member of groups S or A to the Commander-in-Chief](#)

Participants in Group S must direct 100% of their attention exclusively "forward." Any waste of attention on "turning Back" = slowing down the movement of the group, and therefore the entire group "A". During the "battle" this is unacceptable.

If by a sole decision to remove one member of the group, then the rest will cease to believe in the security of their position, productivity will fall and will NEVER be at its highest: people will lose FAITH. And for the success of the reform, maximum dedication is needed.

To prevent such developments,
only the FULL composition of group "S" can be appointed/replaced, only the full composition can be assigned, but not individuals.

This rule is announced publicly by the Commander-in-Chief
: guarantee of rule reliability.

The rule can only be applied once: if the reform fails.

The inapplicability of such a rule is a guarantee to each member of group S of the stability of his position. This makes it unnecessary to worry about protecting yourself, therefore, it does not distract a person's attention from "looking only forward"

Deputy of each head of the site (functional).

If a person is an enthusiast and artist of his craft, then he will devote himself 100% to his work, that is, work "to the max." Working "to the point of wear and tear" leads to a decrease in the quality of human work, therefore this cannot be allowed. To prevent wear and tear, each head of the function will be FORCEDLY sent to intensive measures for his psychological recovery. The decision about who should go for recovery and when is made by group "B"

The Deputy Head of the function is needed primarily to maintain the functioning of the Site for the period psychological recovery of the Head of the function.
This will also be necessary for emergencies..

The decisions of group S must be binding for each member of group "A". The is, as it were, the first deputy commander-in-chief for reform issues.

It goes without saying that group "S"and A will work in very close information and targeted contacts, therefore, significant contradictions cannot arise.

Tensions in relationships should be prevented and eliminated by group "B", therefore, it is expected that there will not be even noticeable contradictions between A and "B".

Add a "deputy for reform" to some ministers.

Usually, ministerial positions are given to people who are balanced and "correct"
= stability of the country

Carrying out our reform is PLANNED INSTABILITY of the country

Along with the "leisurely" minister, a "hasty" deputy for reform issues must be appointed.
Fundamental disagreements between a deputy and a minister are resolved only by the Commander-in-Chief. Unprincipled ones are decided by meetings: either with other members of group A, or with group "S".

So that the minister does not see the "young" deputy as his own competitor, and, therefore, so that he does not interfere with the work of the deputy,

it is required that it be initially announced by the Commander-in-Chief that a deputy can hold the position of minister only:
and with the consent of the minister himself
and the absence of "against" from at least one member of the Government.

Then Experience and Energy will strengthen each other.

Representative of the "personnel team" of the Commander-in-Chief.

Task =

involve the Commander-in-Chief
to resolve specific contradictions between groups "S" and A
on time = with ADVANCE of negative developments.

What are "specific" contradictions =

those contradictions that arise due to the difference in mentality between "outsiders" - group S and "locals" - group A. (This also includes the political component of the phenomenon of the formation of local authorities).

Function =

timely informing the Commander-in-Chief about everything that the Representative considers important from the point of view of the above.

Any government is inertial.
Any "assault" squad is dynamic.

Contradictions, and PERMANENT ones, between group A and group S are inevitable. But "technically" they can be solved.

usually, the mood in the governments of stable countries is distributed as follows:
a third of government members = I want,
a third - don't mind,
a third - I don't want.

That is, "wanting" will, on average, = 50%.

*
Any phenomenon develops when 2/3 of its body is "for".

=
Such a government will not be able to implement reform.

*
The will of the Commander-in-Chief and his "personnel" is required.

That is why without a Commander-in-Chief - romance and enthusiasm, reform in peacetime is impossible.

This will add about 1/6 of the phenomenon, which together will provide 66% "for".

Then the remaining 33% will be divided like this:

16% (=1/6) - not against

16% (=1/6) - I don't want.

1/6 is a lot, but it can certainly be overcome.

This is why it is required [Representative of the "personnel team" of the Commander-in-Chief](#)

Removal of an uncooperative member of group "S".

This decision is made by ANY ONE of the specialists in group "B".

To prevent/reduce grievances and useless conversations, the decision is announced by the Commander-in-Chief.

Specialist "B" is strongly recommended NOT to JUSTIFY his decision even among members of group "B".

Causes:

1) after making a decision, wasting the time and energy of group members discussing something that can no longer bring benefit to the cause (and both must be protected) is harmful;

2) group members "S" will become afraid of this member of group B, which will entail a CONSTANT diversion of their attention from "just forward"

3) new specialist in the group "S" will be aware of the considerations of each of their group "B" (in the usual working order),

and it is of no use to him to know why exactly the previous performer was suspended.

When each Member of Group "B"

=

knows that his decision is decisive and will not be canceled even by the Commander-in-Chief

= that is, the consequences of replacing a key "commander" will fall only on his conscience

*

each member of group "B" = "supportive" of the cause no less than any other.

Consequently, the very fact of replacing one of the key figures is extremely unprofitable for him

=

in the end, he will do everything possible to resolve any conflict without losses,

and only in extreme cases will he apply his "post-Veto" right to such and such a person.

Yes, such a situation is practically impossible, BUT

such a right is NOT given for its use,

and for 100% CONCENTRATION of ATTENTION of member of group "B" on ONLY positive options for solving problems.

(Will you think about using the guillotine if you know that you can do it at any moment?)

Peculiarity:

But a member of group "B" might just make a mistake?

There is no mistake: the process of finding a solution to prevent the next conflict is a collegial process in the "S" group. And everyone together cannot make a mistake. (They may fail, but they won't make mistakes).

At the request of any member of groups S or A to the Commander-in-Chief
* decision of the Commander-in-Chief.

The task of group "B" is to ensure that there is no conflict between any member of group A and group "S".

Why is the opinion of one member sufficient from group A, but the opinion of the entire group is necessary from group B? ---

The failure of a task is manifested in the fact that some conflict remains unresolved to such an extent that it stops work on such and such a task.

The latter will force the party to the conflict to turn to the "last resort" - the Commander-in-Chief. If this happens, it means that group "B" did not cope with the task.

The reason for this may also be the lack of effectiveness of someone in the group; in this case, an effective solution would be to replace it.

The above is reflected in the formula:

at the proposal of any member of Groups S or A

Sellers of consumer goods (retail).

The owner will think like this:

- If I'm straining, and you're not straining (compare IOP from yourself and from the Buyer) - I won't give it to you, But if you're also stressed, I'll be happy to give it to you.

If the Buyer does not show his Index, the Seller will not give him anything.

If I produce \ distribute luxury goods or social deficit,
then I will give it only to those who have a high index.

Only those who "give all their best" in their activities will be able to receive a high index,
which ensures that their interest lies not in the sphere of consumption, but in the sphere of production,
which ensures that these people acquire luxury \ scarcity for something useful,
which, in turn, will create conditions for them to perform even more effective personal activities.

Owner and accounting profit.

Since accounting profit does not allow saving,
but it is a means of increasing the company's efficiency,
consequently, index increases,
then the owners of the companies will begin to think more and more in this direction.

Moreover, it will be beneficial not so much to increase the quantity of the product as to make it more appealing to buyers.
Novelty will not be introduced to increase the price, even by deceiving the consumer,
but to qualitatively satisfy his needs.

The process of improving the company's product will become continuous in the country,
which will require technology upgrades,
which will increase demand from Manufacturers for new technologies,
which will ensure CONTINUOUS technological growth of the country,
and, since the source of this growth will be the interest of ALL the people,
then growth will be rapid and self-adjusting between sectors of the economy.
The latter is extremely convenient for managing the economic development of the country.

Thus, the interest of both the Distributor and the Producer moves towards increasing the rating = towards strengthening reforms, towards the formation of a new (non-accumulative) system of values, a new civilization.

The country will develop with an efficiency 5-10 times higher than usual.

On the one hand, they need profit to expand their activities,

companies producing means of production (commodity values for the Manufacturer) will:

+ quantity (up to not lower than the best indicators in the product category)

+ elements of the quality of its production are limitless: for the Consumer will evaluate highly only what is better than the previous one.

The process of distribution by indices, based on the laws of personality psychology: simplified:

"If I work a lot, then the one who works a little is bad," -

will lead to the fact that

those with high indices will be given the best,

but those with low indices - the worst.

To have a high index you need to work better than others,

and for this you need to direct all your efforts to improve your work.

and to improve work, it is necessary, among other things, to acquire certain consumer values. These are the values that will become the most DESIRED.

If attention is focused on one thing, then it turns to the rest in small quantities. This means that other consumer values will no longer be DESIRED.

The following consumer values are unnecessary to improve operational efficiency:

--luxury: fashionable cars, luxury housing, expensive jewelry, etc.,

--"new" goods, in which there is no new real utility, but which are imposed on the population in the pursuit of making more profit than a competitor: the overconsumption market.

An effective employee of the country WILL NOT WANT such goods and services.

This will cause a change in the market for the required values in the country.

And this will change the direction of the use of funds by distribution companies and manufacturing companies. As a result, Distributors and Manufacturers will WISH:

produce and provide something that will help the population increase labor efficiency

(But not that "it's more profitable to sell").

On the other hand, the dependence of the indices of all company participants on the assessment by Consumers will create a DESIRE to improve the quality of products/services

(But not to impose on the consumer a bunch of the same thing, but in a different wrapper)

China 1990-2017
Imperial Russia 1887-1913

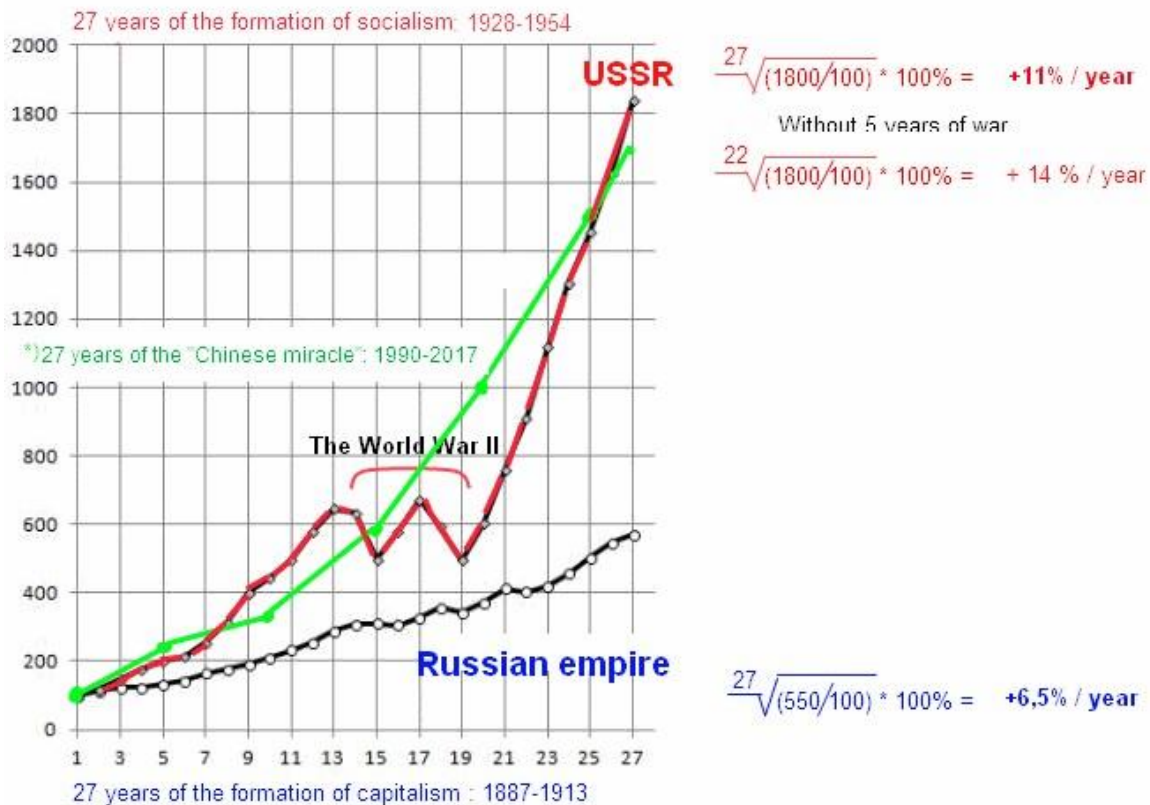
The reason for the record growth was:

Imperial Russia = transfer of the economy to a capitalist mode of production with the involvement of international capital.

USSR = transition of the economy to a social mode of production - "socialism".

China = public economy opened up to international capital (through the annexation of Hong Kong)

**Rate of industrial development
THE SAME people
located in different civilizations.**



China - after the whole West began to invest in it (Hong Kong), shows the SAME pace as the USSR with limited investment

We see that the growth of the USSR and China (for the corresponding periods) is the same. What does it mean? That an economy built on the basis of the **ENTHUSIASM OF THE POPULATION** gives the **SAME EFFICIENCY** as an economy built on the **PURSUIT OF MONEY**.

What will happen if it happens in some country and a rapid rise in the enthusiasm of the population

and large-scale investment growth?

The growth rate in the USSR ("enthusiasm") exceeded the growth rate of the Russian Empire ("pursuit of money") by 2 times!

This means that if a revolution were to take place in China today, giving rise to the enthusiasm of the population, then the rate of development would DOUBLE, and amount to 22% per annum, steadily, for many years.

And this is not growth in some narrow sector of the economy, but in all major areas.

That is, individual industries would grow for several years at a rate 1.5 times higher than the average = 33% per year.

Fantastic ? No: psychology of personality and groups.

Facts:

No. 1:

The civil war in Russia in 1918-1922 - the battle of Tsaritsyn. Delivery of artillery (and ammunition). It was necessary to bring heavy guns, which were 600 km away, in 6 hours. This is an almost impossible task even in modern conditions, but then the soldiers and people WERE ABLE to do it.

№3:

World War II - USSR - time required to bring a heavy artillery gun into action - number of soldiers = 3. After the war, in peacetime, at least 10 soldiers could repeat the same thing during exercises.

After World War II. Exercises. Task: a truck with a heavy gun must drive to a certain point, and the gun crew must bring the gun to combat readiness. Standard time - 60 seconds.

The military of the German Democratic Republic and the USSR participated.

The Germans completed the task in 45 seconds, the "Russians" - in 25.

The reason for such speed among the "Russians" is that the winner of World War II = the ultimate desire to win in any situation.

(ESPECIALLY indicative for industrially UNDERDEVELOPED countries)

The beginning of the civil war in the Russian Empire and the end of the First World War (1917-1922). To protect the new government, millions of new fighters are needed, but:

1) the country has already suffered heavy losses at the front: up to 1.8 million soldiers (:ⁱ) and 13 mil civilians (:ⁱⁱ)

2) the country is half depopulated: population 1914 = 166 million, 1917 = 91 million, = 55% (:ⁱⁱⁱ).

3) The remaining male population fit for war (estimated) was < 15 million.

The size of the Red Army:

beginning of 1918: < 0.2 million soldiers,

+ 1.5 years (heaviest losses: in mid-1918 the new government controlled only ¼ of the country): 3 million.

+ 1 year (1920): 5.4 million.

Where did such a colossal increase in soldiers come from:

5.4 million + 1.8 million dead - 0.2 million at the beginning of the war
= 7 million people
= almost half of the remaining corresponding male population of the country.

"Driven together"? In order to lose the power they had just won?

They didn't drive together: all mobilizations were carried out exclusively among the poor, and "class enemies" were not even sent to die.

Who could have done it?

Let us compare the strength of the mobilization of the Russian Empire in 1914 and the strength of the new country in 1918:

Moreover, the most "underdeveloped" ones went - the peasants.

: the issue of changing housing is one of the most inert in people's lives, which entails a loss of time and enthusiasm, and such losses on a large scale will significantly slow down the effect of the reform.

What will a "mobile city" look like? This is a "technical" question, that is, one that can be decided beforehand. (Although we have specific considerations on this topic).

At a glance, a "mobile city" is seen as follows:

then it will be BENEFICIAL for him to spend his time on legal proceedings,
and he will go to court.

Explanation.

Political economy side.

Money in the consumer sector of the economy currently performs the following functions:

- measure of value,
- measure of price for Luxury,
- means of accounting for debts ("payment"),
- and means of coercion to labor.

1)

Measure of value

= measure of labor = life of people spent on production of Consumer value (:thing, work, service)

is used in the economy of the main mass of producers - mercenaries

2)

Measure of price for Luxury

= measure of proportion of demand from "employers" (representatives of the social class, having financial opportunities by orders of magnitude greater than mercenaries), and the quantity of consumer values

(which are necessary not for the production of their labor force, but for ensuring the socio-psychological significance of the owner) - luxury.

3)

Means of accounting for debts ("payment")

4)

Means of coercing to labor and taking away it (part).

It is applied by the political system of the modern commodity society.

What and how does the Reform change.

1)

The measure of SPENT LIFE of people on the production of Consumer values is replaced by the MEASURE of ACQUIRED LIFE from the consumption of these values, when the Consumer value is assessed not by its "labor costs", but by its "life profit".

It is this function of the Social assessment that makes possible and inevitable the outburst of enormous productive energy in the Mercenaries, which forms the economic (along with the psychological) benefit of the reform.

2)

The measure of the price of Luxury does not change.

The reform only slightly changes the form of using this measure:

an individual purchases Luxury not in his own name, but in the name of his company, but uses it as before.

3)

Means of accounting for debts ("payment").

The phenomenon of personal monetary debts is made impossible by the Reform, therefore its existence ceases.

4)

Means of forcing to work and taking away (part of it).

This phenomenon is not specifically political economy, but is political economics.

This phenomenon ceases to exist due to economic insolvency at this stage of human development.

Differences between the reform and historical analogues

TOTAL = The possible reasons for the beginning of the Reform are COMPLETELY different from the reasons for the historical analogue

Why do you need to know this?

If the reasons for the proposed reform were similar to the reasons for that event, then the reform was doomed.

The closest (?only) similar phenomenon is War Communism in Russia in 1918-1921.
It was during the War Communism that money was abolished for the first time in Russia.

Reasons for War Communism and the Abolition of Money --- .

The termination of commodity relations, as a result of which money became NOT NEEDED by any social class.

The reason for commodity relations = the impossibility of providing the Village with the City's products in quantities sufficient even for simple reproduction.

The reason for the impossibility = a long war that bled the industry dry

Reasons for the reform :

1.

the impossibility of increasing the efficiency of the country's economy

Reason = exhaustion of exploitation possibilities

2.

and as a consequence - the threat of loss of power

Reasons:

2.1. or redistribution of economic and political resources of countries within the framework of interstate relations (economic unions, blocs and wars within them);

2.2. or the struggle for control over the profits from the sale of the country's mineral resources;

2.3 or both.

Conclusion:

The possible reasons for the beginning of the Reform are COMPLETELY different from the reasons for the historical analogue.

Reasons for War Communism and the Abolition of Money.

During the war, the country's industry experienced exactly **critical** decline.
The phenomenon turned out to be at the level **impossibilities** recovery **in the old ways**.

According to the law of Probability Theory, it is possible to "restore" a critically destroyed phenomenon – industrial production –
it is possible only by the methods of the NEW phenomenon, which are FUNDAMENTALLY different from the methods of the Old.

Then only material forms would remain from the old phenomenon,
but on the basis of which a completely different device was assembled with much better characteristics.

A qualitatively new method of construction (not restoration, but rather re-construction) of industry
there was not a spontaneous (market) but a centralized (PLANNED) organization of production and consumption.

This law of Probability Theory inevitably led to
first the change of power from the landed aristocracy to the power of the industrial bourgeoisie,
and then to the change of power of the latter to the power of the poor.

Thus,
not the ideological "wants" of this or that political group,
not political reshuffles, not administrative measures, and not even forceful decisions,
but the OBJECTIVE laws of existence of a socio-economic organism (country) controlled the situation.

Yes, economic calculations of that time could show that Russia could not withstand participation in the war for many years:

BUT the decline of the French economy "lagged" behind the Russian one by only 1 year: see → [20250329131510](#) .
however, in 1918,

when in France the fall in GDP per capita turned out to be EVEN DEEPER than the "revolutionary" level in Russia in 1917,
there was no change of power in France.

Yes, both in the army, and in the Navy, and among the workers, there was unprecedented political and military
disobedience, but even if the international war (and the fall in GDP) had continued for years, class power in France WOULD
NOT HAVE CHANGED.

France is a clear example of the fact that GDP (and, even more so, more detailed indicators) cannot change power.

Military losses

See the population losses of the countries participating in the war, % see in "[Damage from the entire population, %](#)"
Russia suffered not just the smallest losses, but 2-4 times less than the main participants in the war (and more than 4 times
less than France), but there was no change of power in them (and it was not even visible).

Hunger.

How can a phenomenon like hunger influence the government if it kills 1/3 of the country's population?

This did not happen during the First World War.

During the period of political upheaval, there were not even cases of mass death.

Why did **two** changes of class power occur in the underdeveloped and populous Russia in **one year** (1917)?
 Because it turned out to be DECISIVE **population ratio "City" - "Village"**.
 In Russia, rural residents -85% in France - 59, in Germany - 44.
 That is, the "revolutionary" proportion lay between the Russian 85% and the French 59%.
 Where exactly is not relevant to our topic.

How this proportion WORKS for social upheavals.

It was previously stated that the process of destruction of the "money" economy is becoming irreversible, this is when a growing one is formed **insufficient supply of the City economy of the Village**.

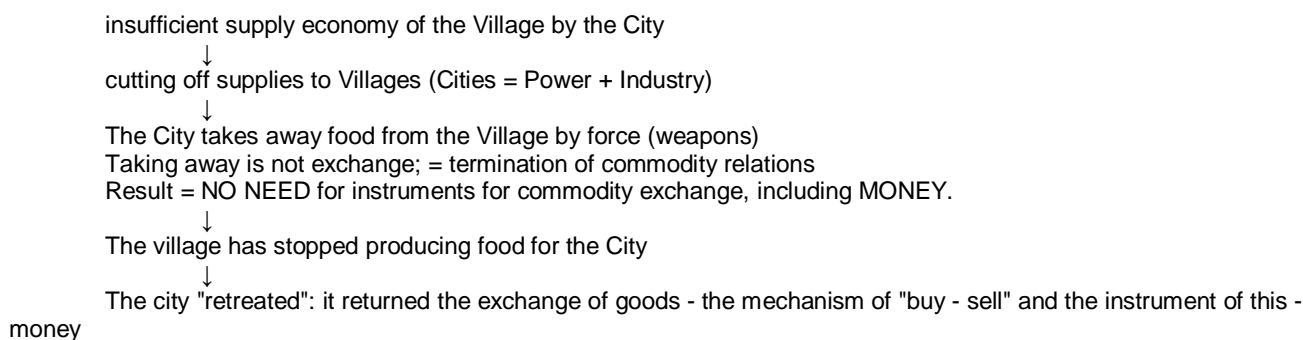
The larger the population of the Village, and the smaller the population of the City, the
 The Village needs more of the City's production in PHYSICAL terms (not in monetary terms),
 this means that "Gorodzhnin" should produce MORE products,
 but the smaller the City, the more problematic it is to do this.
 There is a certain ratio: % of the City's population to % of the "Village's" population, - below which
 the City PHYSICALLY cannot produce in 1 year as much as the Village needs to spend in 1 year.
 It is unknown the country (and such a thing is impossible) when the City has 5% of the population (including the Authority),
 and it was able to provide 95% of the industrial expenses of the Village.

Thus, **abolition of money** In Russia, two phenomena were "made":

Static: **population proportion** City - Village
 +
 Dynamic: **big war**, which "ate" the City's capacity, which was intended for the Village.

It was they who started the accelerating process of destruction of power ("revolutions") : first - of the aristocracy, then - of the industrial bourgeoisie.
 Exactly **physical exchange of consumer values "City - Village"** - the first basis of economic stability (and power) in industrially developing countries. This is the power-forming basis of society.

After the change of economy from market to planned
 The chain of events in Russia went as follows:



TOTAL:

The basic reason for the "abolition of money" (both in the Consumer and in the Productive sectors of the economy) were

proportion PHYSICAL economy of the country: City - Village
 +
 war = "accelerator" of failure to provide the City for the Village
 = **PHYSICAL** reduction of the Means of Production in the City working for the Village.

(and not problems with loans, prices or political conjuncture),

To restore the shortage of industrial capacity of the City to the volume of productive needs of the Village
 It was no longer possible to do so using commodity methods alone, either physically or theoretically.

The NATURAL phenomenon of "market/commodity economy" has inevitably "swung" towards a new PHENOMENON of economy - "planned/distributive".
 The short lifespan (75 years) of such an economy is dictated by the same Probability Theory, namely, "transient processes" (They are studied in any technical institute and they are universal for any natural phenomenon.)

It is IMPORTANT to note that already then - 1921 - the ruling "Marxists" thereby QUALITATIVELY turned away from their ideology - the construction of "communism" (although, quantitatively: not to allow large private savings to form - they continued to move) and that is why the country began to develop "half-way", and that is why instead of "USSR" today the world has "RF".

After all, the founder of the theory of communism, Marx, proved with formulas that communism:

- 1) can only arise in an industrially developed country,
- 2) and it can "sustain" only if it arises in all leading industrially developed countries.

That is, for the rulers of Russia at that time (including the founder of the NEP - V.I. Lenin) the main task was - TO HOLD ON TO POWER = FEAR of losing opportunities for self-realization and life itself. This is natural for ANY government at ANY time, and it EMPHASISES that

the truly effective ideas are those that rely on
phenomena of NATURE: on "physics" and "psychology",
and not on human "games": on "power" or "money".

Secondary cause = administrative and economic printing of money not backed by commodity mass.
: the "simplest" way to quickly stop the growing economic problems

Facts: The issue of Prikamskaya Zhizn from February 8, 1917 reports on how conscripts influence inflation. According to the newspaper, having a good salary, they come to the markets and buy up products, not really bargaining. And thus, quite understandably, they increase their price.

Tertiary cause = psychological and economic the Village's reluctance to sell at reduced (= "hard", "fixed") prices.

Facts: By February 1917, the task of supplying the urban population with bread was only 30% completed. In Petrograd, which was already living on reserves, 714 thousand poods of flour remained. They brought in 5 thousand poods per day, with the norm being 60 thousand poods.

Wants of government leaders

--

The bearers of new ideological ideas, Marxists, came to power. They had their own theoretical "wants", including replacing commodity relations with centralized distribution relations. They justified the abolition of money with these words:

Fact: the speech of the man whose leader of the revolution was V.I. Lenin.^{xii} named:
".. the most valuable and greatest theoretician of the party"

^{xiii} *"Othe experience of economic movement has shown us, how wrong were ours old performance s about the achievements of socialism after the conquest of state power by the proletariat.*

*Roughly speaking, we used to imagine things like this:
we are conquering power,
we take almost everything into our own hands,
let's start right away planned farm,
some trifles there, which are sticking out, we partly take on the tsugunder, partly we overcome,
and that's where it ends."*

It turned out that it is precisely physical "trifles" that are stronger than ideological "ideas".

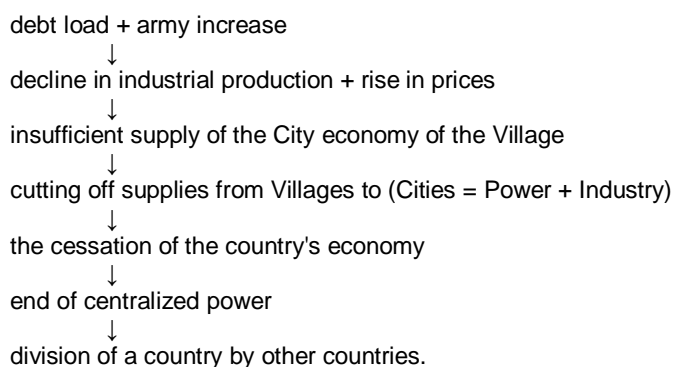

Based on GDP, Russia could fight painlessly for only ONE year.

After that, due to weak GDP per capita, Russia would be forced

- 1) to continue the war, take loans from more economically powerful countries (England, France, USA);
- 2) compensate for the lack of military power by increasing the size of the army.

Such a process, once started, became continuous, and a chain of phenomena began to work:



The facts show:

After only 2.5 years, Russia was ON THE VERGE of being unable to stop the collapse (political consequence - replacement of the monarchy with the bourgeoisie)

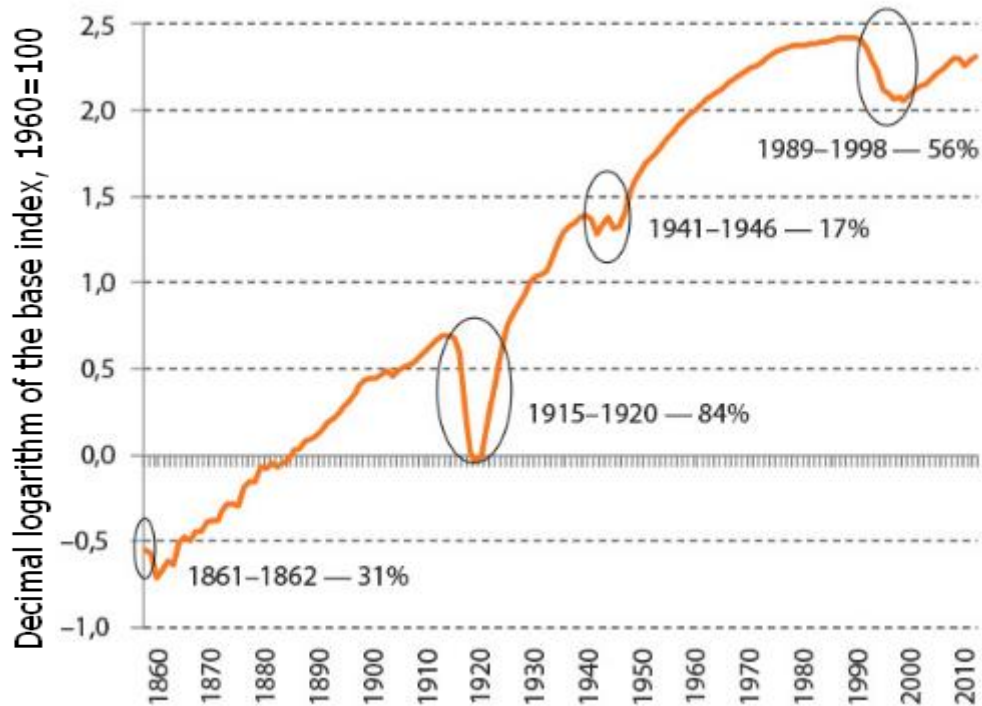
And after another 1.5 years, Russia collapsed to its theoretical limit (political consequence - replacement of the power of the bourgeoisie with the power of the poor)

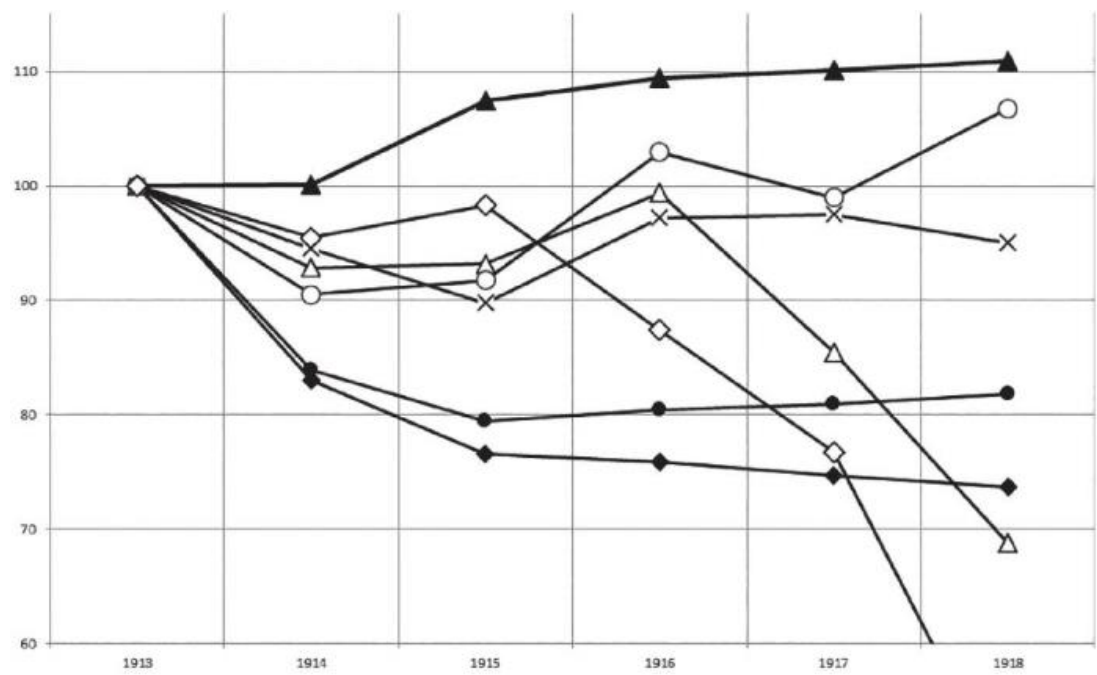
